By intentionally planning for utility affordability, the BLP can keep rates competitive even as the industry changes rapidly. For nearly a decade, the BLP has offered customers highly competitive prices through **smart investments, joint action opportunities, and support from industry experts.**



By taking advantage of these opportunities, often in partnership with public power utilities across the state, we have structured our power supply portfolio to handle market volatility, diversify energy investments, and comply with changing regulations. This is critical to the stability of your power bill!

What happens if we only protect price though?

If we focused too much on affordability, we could risk compromising our reliable infrastructure by holding back on important upgrades. Likewise, too much focus on low rates would prevent us from integrating sustainable energy sources.

The Future is Sustainable

Sustainability is a crucial aspect of effectively managing utilities and ensuring the BLP's competitiveness in the future. Over the past decade, transitioning to a diverse power supply portfolio has resulted in:

A nearly **70% reduction in local carbon emissions** since 2005.

2 The BLP incorporating over 24% renewable energy commitments into its portfolio over the past seven years, with more exciting projects on the way.

> The BLP's energy waste reduction program cumulatively **saving** over 10% of its annual energy sales.

These efforts have resulted in long-term benefits for energy efficiency and sustainability, earning the BLP the top-tier **Smart Energy Provider** designation from APPA.

However, if the BLP places too much emphasis on sustainability, it could negatively impact reliability and affordability. This is due to potential infrastructure limitations and the variable nature of renewable energy sources.
